Explanation of the Purpose of the Proposed Rule and the reason(s) for proposing the rule:

The proposed amendments to Rules 4, 8, and 11 are the result of the revision of the Registered Professional Geologist Practice Act, effective July 1, 2006. Rule 4 is being revised to clarify and revise fees charged and change renewals and enrollment fees from a biennial to annual basis. Rule 8 is being revised to clarify what materials are allowed in the examination room when a geologic competency examination is being administered. Rule 8 is being revised to be in compliance with the language contained in the revised Act that was effective July 1, 2006.
